You carry out re-active, planned and preventative electrical work including improvement works within the building. You complete general maintenance duties to ensure the smooth operation of the building including pool plant duties within the technical team rota.

GUIDELINES AND EXPECTATIONS

Authorities & Limitations

- Survey, measure and order materials for the work required
- Offer and provide effective technical solutions to problems through investigation and analysis and know when to refer to the RCP Technical Officer or the Property and FM team.
- Ensure that H & S requirements including the use of protective equipment.
- Support the Technical Supervisor in the development and delivery of planned maintenance work schedules
- Assist with electrical work across the Edinburgh Leisure estate as required
- Monitor and where necessary change the water quality parameters in the pools in consultation with the RCP & pool water technical manager.
- Use technical judgement to complete repairs and maintenance tasks on a day to day basis from the job book referring to the Technical Officer for more complicated/unusual tasks.
- Use your technical knowledge to advise others in the correct use of RCP equipment e.g. sound systems, moving floors or lighting etc.
- Follow the procedures for facility opening/closing, use of the equipment completing checks and records as required
- Ensure contractors follow EL guidelines

Communication & Representing The Organisation

- Communicate effectively with your supervisor, centre management and colleagues to ensure information about faults, break downs and actions to address.
- Behave with courtesy to colleagues and customers minimising disruption to customer service
- Provide support to other trade groups to maintain high levels of serviceability for our customers.
- Use your technical expertise and knowledge to influence others to follow a particular course of action
- Contribute ideas for improvements and developments to colleagues.
- Complete records accurately

Safeguarding Our Customers

- Comply with relevant Health and Safety Regulations and follow the correct Health and Safety procedures as required by current legislation and Company practice including using tools, working at heights, lone working, manual handling and personal protective equipment.
- Ensure through Risk Assessments and Method Statements that risk, impact and
 effect to customers and other staff is minimised. You will be responsible for
 ensuring that the pool water at the RCP is safe (chemically) and comfortable
 (temperature) and that the technical, electrical and mechanical installations are fit
 for use by the staff and the customers.
- You will be handling and storing hazardous chemicals and are responsible for doing so in a safe manner.
- You will protect staff and customers from injury when carrying out maintenance within the building.

Problem Solving

- Respond quickly and effectively to events that could lead to closure or part closure
 of a facility as a result, for example, of structural failure, power supply distribution
 failure, power systems failure, emergency systems failure, vandalism.
- As the electrical subject matter expert be prepared to offer and provide effective technical solutions to problems through investigation and analysis and know when to refer for assistance.
- You analyse pool monitoring systems readings and resolve any issues
- The RCP has a range of specialist and technical equipment. You need to stay calm and focussed and work methodically through technical, electrical and mechanical issues when they arise to get the systems/conditions back to acceptable parameters to minimise closures.

Impact On Organization

This role is critical to the smooth and safe running of the RCP in relation to all technical, electrical and mechanical systems, which in turn reflects positively on Edinburgh Leisure and the service we deliver to customers.

JOB DEMANDS	
Physical	This post demands 'hands on' working practice and you will be expected to be conversant with the demands contained within a sports and leisure built environment. This includes; working at height; manual handling and exposure to pool chemicals. The role involves climbing access platforms, working on roofs, ladders, steps and powered access. Bending, stretching, standing and crouching in addition to the strength and manual handling requirements (80% +). The post is part of a shift pattern including evenings and weekends and to work hours e.g. overnight to meet the needs of the service to minimise disruption to customers or as a result of an emergency or breakdown.
Mental	This role requires alertness and professionalism as you will be expected to anticipate and respond to situations appropriately. Much of your work is planned/ preventive maintenance, however you must quickly adapt and respond when faced with break-downs and possible service failure. Your analysis of problems and your decision making is crucial where you are seen as the subject matter expert in electrical maintenance matters as well as general technical issues; you need to know when to act and when to refer.
Emotional	This role involves working within a team of technicians at RCP and other members of Edinburgh Leisure staff as well as our customers. At times you work unsupervised. You must analyse problems calmly and systematically in order to take the appropriate action and prevent a situation worsening.
Environmental	You are required to work in a variety of environments both indoor and outdoor. There is working at heights, the role involves building and climbing access platforms and ladders to work. You are exposed to differing levels of temperature, humidity and noise, you are working with pool chemicals and are required to wear the appropriate PPE. You operate on your own and unsupervised at times within the centre. A reasonable level of fitness is required to carry out this role.
